## SECTION 4: First aid measures

## 4.1 Description of first aid measures

### General information:

In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and seek medical advice.

### Inhalation:

Remove to fresh air. Keep person warm and at rest. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel.

### Skin contact:

Remove contaminated clothing and shoes. Wash skin thoroughly with soap and water or use recognized skin cleanser. Do NOT use solvents or thinners. In case of accidental skin contact, avoid concurrent exposure to the sun or other sources of UV light which may increase the sensitivity of skin.

### Eye contact:

Check for and remove any contact lenses. Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open. Seek immediate medical attention/advice.

### Ingestion:

Get medical attention immediately. Call a physician. Remove dentures if any. Remove victim to fresh air and keep at rest in a position comfortable for breathing. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Chemical burns must be treated promptly by a physician. Give nothing by mouth. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

### Self-protection of the first aider:

No action shall be taken involving any personal risk or without suitable training. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Wash contaminated clothing thoroughly with water before removing it, or wear gloves.

## 4.3 Indication of any immediate medical attention and special treatment needed

**Notes for the doctor:** In case of inhalation of decomposition products in a fire, symptoms may be delayed. The exposed person may need to be kept under medical surveillance for 48 hours.

## SECTION 5: Firefighting measures

### 5.1 Extinguishing media:

#### Suitable extinguishing media:

Use fire-extinguishing media suitable for the surrounding fire. Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog.

#### Unsuitable extinguishing media:

Do not use water jet as an extinguisher, as this will spread the fire.

### 5.2 Special hazards arising from the substance or mixture

#### Hazards from the substance or mixture:

In a fire or if heated, a pressure increase will occur, and the container may burst. This material is harmful to aquatic life with long lasting effects. Fire water contaminated with this material must be contained and prevented from being discharged to any waterway, sewer or drain.

#### Hazardous thermal decomposition products:

Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard.

### 5.3 Advice for fire-fighters

#### Special protective actions for fire-fighters:

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Do not release runoff from fire to drains or watercourses.

#### Special protective equipment for fire-fighters:

Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode. Clothing for fire-fighters (including helmets, protective boots and gloves) conforming to European standard EN 469 will provide a basic level of protection for chemical incidents.

### 6.1 Personal precautions, protective equipment and emergency procedures

#### For non-emergency personnel:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Do not breathe vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment.

### 7.1 Precautions for safe handling

Use only in well-ventilated areas. Keep container tightly closed. Keep away from heat, sparks and flame. Avoid contact with skin and eyes. Avoid the inhalation of dust, particulates, spray or mist arising from the application of this mixture. Remove contaminated clothing and protective equipment before entering eating areas. Workers should wash hands and face before eating, drinking and smoking. Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed.
